Rules and Eligibility Criteria

Three Year (Honours / General) Degree Programme

1. Passed H.S./Equivalent level examination in the year 2018, 2019, 2020, and 2021. No marks will be deducted for the applicants with gap year(s).

2. For eligibility criteria follow Annexure- I

3. For admission in Hons./Gen. Degree Programme 1st year 1st Semester Merit list will be prepared as per University Notification No. RC/UG-PARM/ADMI/2, dated 23.07.2021 by considering percentage of mark obtained in Madhyamic or equivalent examination and percentage of mark obtained in higher secondary or equivalent examination.

4. The criteria for preparing the merit list will be as follows:

Merit list will be prepared by taking 40% of the percentage of aggregate in Madhyamik Pariksha or Equivalent Examination (class 10) and 60% of the percentage of the summation of best five [or best four for those who have passed HS with four subjects], subject marks in HS or equivalent Examination (10+2).

For details of Merit Point calculation, follow Sl. no.18.

5. Environmental Studies will not be considered in the best five subjects if it is taken as Compulsory additional. However, if Environmental Studies is a Compulsory elective with 100 marks, only then it can be included within best five.

6. During application, the selection of the Boards will be as per the Burdwan University approved list vide University Notification No. RC/UG-PARM/ADMI/2 dated 23.07.2021.

7. The students passed (10+2) or equivalent "Vocational Engineering & Technology" examinations (with pass marks in Mathematics) are eligible to apply for 1st Year 1st Semester B.A. (General) and B.Sc. (General) Degree program.

8. The students passed (10+2) or equivalent examinations with "Vocational agriculture" are eligible to apply for 1st Year 1st Semester B.A. (General) and B.Sc. (General) Degree program.

9. The students passed (10+2) or equivalent examinations with "Vocational Business and Commerce" are eligible to apply for 1st Year 1st Semester B.A. (General) and B.Com. (General) Degree program.

10. The students passed (10+2) or equivalent examinations with "Vocational Home" science are eligible to apply for 1st Year 1st Semester B.A. (General) Degree program.

11. State level players with 45% of marks in HS or equivalent examination(10+2) are eligible to apply for admission in 1st Year 1st Semester B.A./B.Sc./B.Com. (Hons) courses. District level players with pass marks in HS or equivalent examination (10+2) are eligible to apply for admission in 1st Year 1st Semester B.A./B.Sc./B.Com. (General) Degree program.

12. The Online Admission Process will be strictly based on merit. Prospective students will not be called for counselling or verification of documents during the process of admission. No physical presence will be required at the college premises during the admission process.

13. Eligible applicants will be informed directly by e-mail and mobile number provided by them. The applicants are strictly advised **not tochange** their **Phone Number** and **mail id** throughout the admission procedure as well as completion of the degree course (in case he/she is selected and admitted). College will not be responsible for any miscommunication due to change of phone no. or mail ID.

14. Payment of admission fees will be done through an online process, only by the selected candidates in successive merit lists which will be published in college web-portal in due time as per available seats for admission in Hooghly Mohsin College.

For reserved category seats (SC/ST/OBC-A/OBC-B), only the applicant with a caste certificate from the appropriate authority of the Government of West Bengal that is acceptable certificates are from

(i) The SDO of a subdivision in a district or

(ii) the District welfare Officer, Kolkata or

(iii) The Ex-officio Joint director, BCW (in Kolkata region) or

(iv) if a candidate do not have SC/ST certificate he/she can produce supporting document that he had applied for the same along with a certificate of his/her father/blood relatives, as per Govt. notification no. 746-L, dated 30.04.2013, 1203-BCW/MR-88/2014 dated 27/07/2015 and Higher Education Department Notification No. 07-Edn (U) / 1U-89/13, dated 2nd January, 2014.

Applicants with Caste Certificate from other States will be treated as General Category.

Admission shallbe summarily cancelled if the documents are found not in conformity with the declaration in the forms submitted online at the time of application. Students are asked to bring all original testimonials at the time of physical verification of documents during reporting for classes in due course, as per notification No. 706-Edn (CS) /10M-95/14 dated 13th July 2021 of Higher Education Department, Govt. of West Bengal.

18. Merit list will be prepared strictly according to merit point.

Merit Point Calculation:--

(A) For all Honours Candidates:

X = The summation of 40% of the percentage of aggregate in Madhyamik Pariksha or Equivalent Examination (class 10) and 60% of the percentage of the summation of best five subject marks in HS or equivalent Examination (10+2). [Those who have passed HS with four subjects, same rule is applicable]

Y = Marks obtained in HS or equivalent examination in the subject applied for Honours

Then Merit point M = X + Y

For making the merit list, if merit points of more than one candidate become identical then marks in Hons. subjects, Marks in English and percentage of mark in Madhyamik pariksha or equivalent examination (class 10) shall be preferred respectively.

Illustration 1: Suppose "**A**" secured 80% marks in MP or equivalent examination. If the sum of **A**'s best five subjects in HS or equivalent examination is 450 out of 500.

Then % of best five subjects is $=\frac{Sum \ of \ Best \ Five \ Sub.}{Total \ of \ Five \ sub.} \times 100 = \frac{450}{500} \times 100 = 90$

Then, X = 40% of 80 + 60% of 90 = 32 + 54 = 85

Illustration 2: Suppose "**B**" secured 80% marks in MP or equivalent examination and "**B**" passed HS with four subjects with 85% marks.

Then, X = 40% of 80 + 60% of 85 = 32 + 51 = 83

(B) FOR AllGENERAL CANDIDATES:

Merit point (M) = Summation of 40% of the percentage of aggregate in Madhyamik Pariksha or Equivalent Examination (class 10) and 60% of the percentage of the summation of best five subject marks in HS or equivalent Examination (10+2) [*Those who have passed HS with four subjects, same rule is applicable*]

If Merit points of more than one candidate become identical then Marks in English and percentage of mark in Madhyamik pariksha or equivalent examination (class 10) shall be preferred respectively.

Illustration 3: Suppose"C" secure 80% marks in MP or equivalent examination.

If the sum of C's best five subjects in HS or equivalent examination is 450 out of 500.

Then % of best five subjects is $=\frac{450}{500} \times 100 = 90$

Then, M = 40% of 80 + 60% of 90 = 32 + 54 = 85

NOTE: i) For Geology Hons., Average of marks of Physics, Chemistry and Mathematics shall be treated as Hons subject mark.

ii) For B.Sc. Economics Hons. marks of Mathematics shall be treated as Hons subject mark.

iii) For those who applied for Hons. in Accounting and Finance, but not coming from Commerce stream, marks of Mathematics shall be treated as Hons subject mark.

i.e. For Accounting and Finance Hons. Y = marks in Mathematics

19. Reservation as per rule: SC 22%, ST 6%, OBC-A 10% & OBC-B 7%, follow Annexure II

20. After filling the form, applicants should get a printout of the submitted form. They are to make a careful scrutiny of the same.

21. During application, candidates should be very careful while uploading marks and other relevant information. Multiple application of one candidate is strongly discouraged.

22. Candidates can avail the application FORM from "*www.hooghlymohsincollege.ac.in*". Candidates need not pay any fees for submission of application form. They can apply for maximum 5 courses i.e. either 4 Honours subjects and 1 General degree program or 3 Honours subjects and 2 General degree program.
